

Viking Completes Global Aerospace Logistics Contract with Delivery of 9th Twin Otter Series 400 Aircraft

Abu Dhabi, United Arab Emirates, February 23rd, 2015: Viking Air Limited of Victoria, British Columbia, has now officially handed over the final Twin Otter Series 400 aircraft on order for Global Aerospace Logistics (GAL), of Abu Dhabi, United Arab Emirates, completing the multi-aircraft purchase contract.

The final aircraft will join the eight Viking Twin Otter Series 400 already delivered to GAL since 2013, being utilized by the UAE Government under a multi-year service contract. The specially equipped Series 400 Twin Otters are configured with paratroop provisions and intermediate flotation gear ("IFG") to enable the Government's operations on the loose sand in the Arabian Gulf region.
